- **Present and potential severe or life-threatening contraindications to the vaccinations / immunizations (as listed above):**
 - hypotonic-hypo-responsive episodes, progressive neurologic disorders, Guillain-Barré syndrome and other types of auto-immune disease including fibromyalgia, macrophage myofascitis, auto-immunity vaccine-related encephalitis, prolonged seizures, life-threatening hyper-immune responses, substantial suppression of cellular immunity, and cardiac arrest.
- **The patient / name listed above is **MEDICALLY INTOLERANT** to formaldehyde.**
- **The patient / name listed above is **MEDICALLY INTOLERANT** to aluminum.**
- **The patient / name listed above is **MEDICALLY INTOLERANT** to mercury.**
- **The patient / name listed above is **MEDICALLY INTOLERANT** to egg protein.**

Excipients Found / Manufactured In The Vaccines (As Listed Above) That Would Cause Serious Or Life-Threatening Contraindications, Allergenic Hyper-Immune Responses, And/Or Reactions To Patient / Name Listed Above:

- **Animal By-Products**
 - Chicken embryonic fluid / chick embryo fibroblast tissue culture, chick kidney cells, ovalbumin (egg albumin), egg / chicken protein, human diploid cells from aborted fetal tissue, washed sheep RBCs, calf skin vesicle fluid, MRC-5 cellular protein, monkey (Vervet or African Green) kidney cells, Rhesus monkey fetal lung / diploid cells, mouse serum protein, mouse brain culture, bovine albumin / gelatin, Linggoud--Fenton / Lathan media containing bovine casein / extract, bovine calf (fetal) serum / protein, guinea pig embryo cells, Medium 199.
- **Growth Mediums & Manufacturing Residues**
 - Human serum albumin (and/or albumin from human blood / human diploid cells or WI-38 from aborted fetal tissue), bacto-peptone, Dulbecco's Modified Eagle Medium (DMEM), hydrocortisone, Tocopheryl hydrogen succinate, yeast protein (especially *Saccharomyces cerevisiae* and GMO yeast), Mueller-Hinton agar, Puziss-Wright medium 1095, Stainer-Scholte medium, soy peptone broth, Watson-Scherp medium, phosphate-buffered saline.
- **Adjuvants / Chemicals / Mutagens / Heavy Metals**
 - MF-59 (Squalene), SV-40 mutagen, aluminum hydroxide, aluminum hydroxyphosphate sulfate, aluminum potassium sulfate, AS-03 adjuvant, aluminum phosphate, ammonium sulfate, aspartame.
- **Antibacterials / Antibiotics**
 - Amphotericin B, chlortetracycline, gentamicin sulphate, neomycin sulfate, polymyxin B sulfate, streptomycin sulfate, kanamycin.
- **Viral Inactivators**
 - Beta-propiolactone.
- **Preservatives**
 - Thimerosal (mercury), benzethonium chloride, ethylenediamine-tetraacetic acid sodium (EDTA), phenol, 2-phenoxyethanol.
- **Dyes**
 - Brilliant green, phenol red (phenolsulfonphthalein) indicator.

- Dextran, cystine, calcium chloride, ferric (III) nitrate, glutamine, magnesium sulfate, sodium hydrogenocarbonate, sodium phosphate, disodium phosphate, sodium pyruvate, magnesium chloride.
- **Toxin Inactivators / Detoxifiers**
 - Formaldehyde, formalin, glutaraldehyde.
- **Stabilizers**
 - Sorbitol, histidine, lactose, monosodium glutamate, potassium glutamate, urea.
- **pH Adjustors / Indicators & Tonicity Adjustors**
 - Hydrochloric acid, disodium, monosodium, sodium dihydrogen phosphate, potassium dihydrogen phosphate, potassium chloride, sodium acetate, sodium bicarbonate, sodium borate, sodium chloride, sodium citrate, sodium hydroxide, potassium monophosphate.
- **Microbes**
 - Polyribosylribitol phosphate, spirochete *Borrelia burgdorferi* recombinant protein (OspA), polysaccharide antigens from *Neisseria meningitidis* bacteria, vaccinia virus, capsular polysaccharides from polyvalent pneumococcal bacteria, fixed-virus / live virus strains.
- **Lubricants**
 - Magnesium stearate.
- **Antifoaming Agents**
 - Polydimethylsiloxane.
- **Surfactants**
 - Polysorbate 80 (Tween-80), polysorbate 20, polyoxyethylene9-10 nonylphenol (Triton N-101, octoxynol 9), polyoxyethylated octyl phenol (ethylene glycol octyl phenyl ether), octoxynol-10, octylphenoxypolyethoxyethanol, p-isooctylphenyl ether, Triton X-100, sodium deoxycholate.
